## **MODE OF MEETING**

Econpile Holdings Berhad ("the Company") will conduct its 11<sup>th</sup> AGM on a virtual basis through live streaming from the broadcast venue and online remote voting via Remote Participation and Voting ("RPV") facilities provided by Tricor Investor & Issuing House Services Sdn. Bhd.'s ("Tricor") via TIIH Online website at https://tiih.online.

The broadcast venue is strictly for the purpose of complying with Section 327(2) of the Companies Act 2016 which requires the Chairperson of the meeting to be present at the main venue of the meeting. Shareholder(s) or proxy(ies) or authorised representative(s) or attorney(s) **WILL NOT BE ALLOWED** to attend the 11<sup>th</sup> AGM in person at the broadcast venue on the day of the meeting.

# **REMOTE PARTICIPATION AND VOTING FACILITIES**

Shareholder(s) or proxy(ies) or authorised representative(s) or attorney(s) are to attend, speak (in the form of real time submission of typed texts) and vote (collectively, "participate") remotely at the 11<sup>th</sup> AGM using RPV facilities provided by Tricor via its TIIH Online website at <a href="https://tiih.online">https://tiih.online</a>.

A shareholder who has appointed a proxy(ies) or attorney(s) or authorised representative(s) to participate at this 11<sup>th</sup> AGM via RPV facilities must request his/her proxy(ies) or authorised representative(s) or attorney(s) to register himself/herself for RPV facilities at TIIH Online website at <a href="https://tiih.online.">https://tiih.online.</a>

(d)	Participate through Live Streaming	<ul> <li>Select the corporate event: "(LIVE STREAM MEETING) ECONPILE 11<sup>th</sup> AGM" to engage in the proceedings of the 11<sup>th</sup> AGM remotely.</li> <li>If you have any question for the Chairperson/ Board, you may use the query box to transmit your question. The Chairperson/ Board will endeavor to respond to questions submitted by remote participants during the 11<sup>th</sup> AGM. If there is time constraint, the responses will be published at the Company's website at the earliest possible, after the meeting.</li> </ul>
(e)	Online Remote Voting	<ul> <li>Voting session commences from 10.00 a.m. on Wednesday, 29 November 2023 until a time when the Chairperson announces the end of the voting session of the 11<sup>th</sup> AGM.</li> <li>Select the corporate event: "(REMOTE VOTING) ECONPILE 11<sup>th</sup> AGM".</li> <li>Read and agree to the Terms &amp; Conditions and confirm the Declaration.</li> <li>Select the CDS account that represents your shareholdings.</li> <li>Indicate your votes for the resolutions that are tabled for voting.</li> <li>Confirm and submit your votes.</li> </ul>
(f)	End of remote participation	Upon the announcement by the Chairperson on the closure of the 11 <sup>th</sup> AGM, the live streaming will end.

## Note to users of the RPV facilities:

- 1. Should your registration for RPV be approved, we will make available to you the rights to join the live stream meeting and to vote remotely. Your login to TIIH Online on the day of meeting will indicate your presence at the virtual meeting.
- 2. The quality of your connection to the live broadcast is dependent on the bandwidth and stability of the internet at your location and the device you use.

# **GENERAL MEETING RECORD OF DEPOSITORS ("ROD")**

## APPOINTMENT OF PROXY OR AUTHORISED REPRESENTATIVE OR ATTORNEY

If you are unable to attend the meeting via RPV facilities on 29 November 2023, you may appoint the Chairperson of the meeting as proxy and indicate the voting instructions in the Proxy Form.

If you wish to participate in the 11<sup>th</sup> AGM, please do not submit any Proxy Form for the 11<sup>th</sup> AGM. You will not be allowed to participate in the 11<sup>th</sup> AGM together with a proxy appointed by you.

Shareholders who appoint proxy(ies) or authorised representative(s) or attorney(s) to participate in the 11<sup>th</sup> AGM must ensure that the duly executed proxy forms and/or documents are deposited in hard copy form or by electronic means in the following manner <u>not later than Monday, 27 November 2023 at 10.00 a.m.</u>:

For corporate members who have appointed corporate representatives, please deposit the **ORIGINAL** certificate of appointment of corporate representative to Tricor not later than **Monday, 27 November 2023 at 10.00 a.m.** to participate via RPV facilities in the 11<sup>th</sup> AGM.

Any authority pursuant to which such an appointment is made by a power of attorney must be deposited with Tricor not later than **Monday**, **27 November 2023 at 10.00 a.m.** to participate via RPV facilities in the 11<sup>th</sup> AGM. A copy of the power of attorney may be accepted provided that it is certified notarially and/or in accordance with the applicable legal requirements in the relevant jurisdiction in which it is executed.

The voting at the 11<sup>th</sup> AGM will be conducted by poll in accordance with Paragraph 8.29A of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad. The Company has appointed Tricor as Poll Administrator to conduct the poll by way of electronic voting (e-voting).

Shareholder(s) or proxy(ies) or corporate representative(s) or attorney(s) can proceed to vote on the resolutions at any time from the commencement of the 11<sup>th</sup> AGM at **10.00 a.m.** on **29 November 2023** but before the end of the voting session which will be announced by the Chairperson of the meeting. Kindly refer to item (e) of the above Procedures for RPV facilities for guidance on how to vote remotely from TIIH Online website.

## PRE-MEETING SUBMISSION OF QUESTION TO THE BOARD OF DIRECTORS

Shareholders may submit questions for the Board in advance of the 11<sup>th</sup> AGM via Tricor's TIIH Online website at <a href="https://tiih.online">https://tiih.online</a> by selecting "e-Services" to login, pose questions and submit electronically not later than **Monday, 27 November 2023 at 10.00 a.m.** The Board will endeavor to answer the questions received at the 11<sup>th</sup> AGM.

There will be **NO distribution** of door gifts or vouchers for shareholders/proxies/authorised representatives/attorneys who participate in the 11<sup>th</sup> AGM.
