#### MODE OF MEETING

In view of the COVID-19 outbreak and as part of the safety measures, the 24<sup>th</sup> Annual General Meeting ("24<sup>th</sup> AGM" or "AGM") of Rubberex Corporation (M) Berhad ("the Company" or "Rubberex") will be conducted entirely through live streaming from the Broadcast Venue. This is in line with the Guidance Note on the Conduct of General Meetings for Listed Issuers issued by the Securities Commission Malaysia on 18 April 2020 (including any amendment that may be made from time to time) ("Guidance Note").

The Broadcast Venue is strictly for the purpose of complying with Section 327(2) of the Companies Act 2016 and Guidance Note which requires the Chairperson of the meeting to be present at the main venue of the meeting. Shareholders/proxies **WILL NOT BE ALLOWED** to attend the 24<sup>th</sup> AGM in person at the Broadcast Venue on the day of the meeting.

## REMOTE PARTICIPATION AND VOTING FACILITIES ("RPV")

Shareholders are to attend, speak (including posing questions to the Board via real time submission of typed texts) and vote (collectively, "participate") remotely at the 24<sup>th</sup> AGM using the RPV provided by Tricor Investor & Issuing House Services Sdn. Bhd. ("Tricor") via its **TIIH Online** website at https://tiih.online.

Shareholders who appoint proxies to participate via RPV in the 24<sup>th</sup> AGM must ensure that the duly executed proxy forms are deposited in a hard copy form or by electronic means to Tricor no later than **Sunday, 5 July 2020 at 10.00 a.m.** 

Authorised representatives of corporate members must deposit their original certificate of appointment of authorised representative to Tricor not later than **Sunday**, **5 July 2020 at 10.00 a.m.** to participate via RPV in the 24<sup>th</sup> AGM.

Attorneys appointed by power of attorney are to deposit their power of attorney with Tricor not later than **Sunday, 5 July 2020 at 10.00 a.m.** to participate via RPV in the 24<sup>th</sup> AGM.

A shareholder who has appointed a proxy or attorney or authorised representative to participate at this 24<sup>th</sup> AGM via RPV must request his/her proxy to register himself/herself for RPV at TIIH Online website at <a href="https://tiih.online.">https://tiih.online.</a>

As the 24<sup>th</sup> AGM of Rubberex is a fully virtual AGM, shareholders who are unable to participate in this 24<sup>th</sup> AGM may appoint the Chairperson of the meeting as his/her proxy and indicate the voting instructions in the proxy form.

- 1. Should your application to join the 24<sup>th</sup> AGM be approved, we will make available to you the rights to join the live streamed meeting and to vote remotely. Your login to TIIH Online on the day of meeting will indicate your presence at the virtual meeting.
- 2. The quality of your connection to the live broadcast is dependent on the bandwidth and stability of the internet at your location and the device you use.

## **Poll Voting**

- The Voting at the 24<sup>th</sup> AGM will be conducted by poll in accordance with Paragraph 8.29A of Bursa Malaysia Securities Berhad Main Market Listing Requirements. The Company has appointed Tricor Investor & Issuing House Services Sdn. Bhd. as Poll Administrator to conduct the poll by way of electronic voting and Asia Securities Sdn. Bhd. as Scrutineers to verify the poll results.
- Shareholders can proceed to vote on the resolutions at any time from the commencement of the 24<sup>th</sup> AGM at 10.00 a.m. but before the end of the voting session which will be announced by the Chairperson of the Meeting. - Upon completion of the voting session for the 24<sup>th</sup> AGM, the Scrutineers will verify and announce the poll results followed by the Chairperson's declaration whether the resolutions are duly passed.
