#### REGISTRATION OF THE DAY OF 116th AGM

- Registration will commence at 8:30 a.m. on 10 June 2026 and will remain open until the conclusion of the 116th AGM or such time as may be determined by the Chairman of the meeting.
- Please present your original National Registration Identity Card (NRIC) or Passport (for non-Malaysian) to the registration staff for verification.
- Upon verification, an identification wristband will be given to you for voting purpose thereafter. No one will be allowed to enter the meeting hall without an identification wristband. There will be no replacement for the identification wristband if it is lost or misplaced.
- Registration must be done in person. No person is allowed to register on behalf of another even with the original NRIC or Passport of the other person.
- The registration counter will handle verification of identify, registration and revocation of proxy/proxies.

#### GENERAL MEETING RECORD OF DEPOSITORS

- Only a member whose name appears on the ROD as at 4 June 2026 shall be entitled to attend, speak and vote (collectively referred to as “**participate**”) at the 116th AGM or appoint proxy(ies) to participate on his/her/its behalf.

#### CORPORATE MEMBERS

- Corporate members who wish to appoint corporate representatives instead of proxy(ies), must deposit their original certificate of appointment of corporate representative to Mega Corporate Services Sdn. Bhd. (“Mega”) before the 116th AGM or bring the original certificate of appointment of corporate representative to the 116th AGM.
- Attorneys appointed by power of attorney are required to deposit their power of attorney with Mega not later than 8 June 2026 at 10:00 a.m. to attend and vote at the 116th AGM.

#### PROXY

The appointment of proxy(ies) may be made in hard copy form or by electronic form in the following manner and must be received by the Company not less than forty-eight (48) hours before the time appointed for holding the 116th AGM or adjourned general meeting at which the person named in the appointment proposes to vote, **otherwise the Proxy Form shall not be treated as valid:-**

a. In hard copy form

In case of an appointment made in hard copy form, the proxy form must be deposited at the office of the Share Registrar of the Company, Mestika Projek (M) Sdn Bhd, 26th Floor Menara KH, Jalan Sultan Ismail, 50250 Kuala Lumpur.

b. By electronic form

After verification, your registration will be reviewed and approved within two (2) working days. A confirmation email will be sent once approved.</li> <li>6. Once you receive the confirmation, activate your account by logging in with your email address and password.</li> </ol> <p><i>Note: The representative of a corporation or institutional shareholder must register as a user in accordance with the above steps before he/she can subscribe to this corporate holder electronic proxy submission.
