## **INFOMINA RECEIVES RM125 MILLION PURCHASE ORDER FROM SIAM COMMERCIAL BANK – CEMENTS PRESENCE IN THAILAND**

**KUALA LUMPUR, 27 DECEMBER 2022 - INFOMINA BERHAD (盈获数码科技集团)** (“Infomina” or “Group”), a leading regional technology solutions provider, announced the receipt of a blanket purchase agreement (“BPA”) amounting to **USD28.44 million (equivalent to RM125.14 million)** (exclusive of service tax) from The Siam Commercial Bank Public Company Limited (“SCB”).

Under the BPA, **Infomina (Thailand) Co., Ltd. (“Infomina TH”)** will provide technology application and infrastructure operations, maintenance and support services and to provide solutions for the improvement and implementation of SCB<sup>X</sup> Group API (Application Programming Interface) gateway in line with SCB<sup>X</sup> Group’s strategy to transform beyond fintech economy. The project will be carried out over a period of **three (3) years** commencing from **1 January 2023 to 31 December 2025**.

Specifically, Infomina TH will upgrade, transform and provide support services to SCB’s core banking applications. Additionally, it is also Infomina TH’s scope to upgrade and expand SCB<sup>X</sup> Group’s API gateway for the transformation of the SCB<sup>X</sup> Group of companies to become a regional financial technology group that creates long-term value and sustainable growth.
