### **Pengkalan Hulu District Council Receives Sponsored Waste Disposal Truck from Malaysia's Largest Tin Mine**

**Perak, 10 August 2018** – Tin miner and metal producer, Malaysia Smelting Corporation Berhad ("MSC" or "the Group") wholly-owned subsidiary, Rahman Hydraulic Tin Sdn. Bhd. ("RHT"), which operates the largest tin mine in Malaysia has sponsored a waste disposal truck for the Pengkalan Hulu District Council.

RHT is the tin mining arm of MSC and operates the country's largest hard-rock open-pit mine located in Klian Intan in the district of Pengkalan Hulu, Perak. It has been in operation for 111 years, since 1907 and contributes to almost half of the country's total tin production.

**Dato' Dr. Patrick Yong, Chief Executive Officer of MSC said,** "Throughout the previous years, the people of Pengkalan Hulu have greatly contributed to RHT's success and it is our sincere hope that this sponsorship will enhance the livelihoods and well-being of the surrounding communities."
