A1 Basis of Preparation

The condensed interim financial statements as at and for the six months ended 30 June 2021 comprise Pavilion REIT and its subsidiaries. The unaudited interim financial statements have been prepared in accordance with MFRS 134, *Interim Financial Reporting* in Malaysia and with IAS 34, *Interim Financial Reporting*, and Paragraph 9.44 of the Listing Requirements of Bursa Securities, provision of the First Amended and Restated Trust Deed dated 18 February 2019 ("the Trust Deed"), the Securities Commission's Guidelines on Real Estate Investment Trusts ("the REITs Guidelines") and the accounting standards, amendments and interpretations where applicable to Pavilion REIT that are effective for annual periods beginning on or after 1 January 2021. They do not include all of the information required for a full set of annual financial statements, and should be read in conjunction with the Audited Financial Report for the year ended 31 December 2020 and the accompanying explanatory notes attached to the interim financial statements.

A2 Audit Report of Preceding Financial Year

There was no qualification to the Pavilion REIT's audit report for the preceding financial year ended 31 December 2020, which was prepared in accordance with Malaysian Financial Reporting Standards and International Financial Reporting Standards.

A3 Significant accounting policies

The accounting policies applied in these condensed interim financial statements are the same as those applied in its consolidated annual financial statements as at and for the year ended 31 December 2020.

A4 Estimates

The preparation of interim financial statements requires management to make judgements, estimates and assumptions that may affect the application of accounting policies and the reported amounts of assets, liabilities, income and expenses. Actual results may differ from these estimates.

In preparing these condensed interim financial statements, the significant judgements made by the Manager in applying the accounting policies and the key sources of estimation were the same as those that were applied to the financial statements as at and for the year ended 31 December 2020, except as disclosed below.

The accounting policy of investment properties as adopted by Pavilion REIT requires investments properties to be stated at fair value. In estimating the fair value of the investment properties, the Manager will rely on professionally qualified valuers at annual reporting dates. However, for interim financial reporting, the fair values of the investment properties are not updated. Asset improvement initiatives undertaken by the management, the economic environment and other factors may change the fair values of the investment properties. When the fair values are updated as at 31 December 2021, the fair values could be materially different from the current carrying value.

A5 Seasonality or Cyclicality of Operations

The business operations of Pavilion REIT are not affected by material seasonal or cyclical factors.

A6 Exceptional or Unusual Item

There were no exceptional or unusual items to be disclosed for the quarter under review other than the Malaysian Government imposing various type of mandatory control order effective from 18 March 2020.

A7 Changes in Estimates

There were no changes in estimates that have had material effect in the current quarter.

A8 Debt and Equity Securities

There were no issuance, cancellation, repurchase, sale and payment of debt and equity securities for the current quarter and year to date except for payment of 25% Manager's management fee paid in Pavilion REIT units, with details as disclosed below.

Quarterly Results

Pavilion REIT recognised total gross revenue of RM124.8 million in Q2 2021, a slight decrease of RM1.6 million or 1% compared to Q2 2020 of RM126.4 million.

Total property operating expenses decreased by RM10.2 million or 12% compared to Q2 2020. This was mainly due to higher provision for doubtful debts in Q2 2020. Nationwide MCO was implemented from 12 May 2021 and shopping malls are not allowed to operate with the exception of tenants that fall under the essential services category. Lower maintenance and marketing expenses were incurred during the period.

These have resulted in higher net property income by RM8.5 million or 22% in Q2 2021 compared to Q2 2020.

Manager's management fee incurred for the Q2 2021 was slightly higher by RM0.2 million compared to Q2 2020 due to higher net property income. Borrowing cost incurred during the quarter was lower by RM2.3 million as compared to Q2 2020 mainly due to lower floating coupon rate for medium term notes.

Distributable income for the quarter under review was RM22.5 million or 0.73 sen per unit, consisting of income after tax of RM20.4 million and non-cash adjustments for depreciation of RM0.1 million, amortisation of borrowing transaction cost of RM0.4 million and 25% of Manager's management fee payable in units amounting to RM1.5 million.

Year-to-Date Results

Total revenue for year-to-date 30 June 2021 was RM251.0 million. It was lower by RM9.7 million or 4% compared to preceding year-to-date 30 June 2020's performance. The decrease was mainly due to lower occupancy rate for shopping malls because of non-renewal of some expired tenancies. Income from marketing events and advertising were also affected.

Total property operating expenses incurred was lower by RM12.0 million or 8% as compared to year-to-date 30 June 2020. This was mainly due to contributions made to the Malaysian Government to support Malaysia's fight against Covid-19 pandemic and higher provision for doubtful debts last year. MCO was implemented from 13 January to 4 March 2021 and nationwide MCO was implemented from 12 May 2021. Shopping malls are not allowed to operate with the exception of tenants that fall under the essential services category. Lower marketing and promotional expenses were incurred during the period.

These have resulted in higher net property income by RM2.3 million or 2% for year-to-date 30 June 2021 as compared to preceding year-to-date 30 June 2020.

Negligible change in Manager's management fee. Borrowing cost was lower by RM6.0 million due to lower floating coupon rate for medium term notes.

Distributable income for the six months ended 30 June 2021 was RM56.0 million or 1.83 sen per unit, consisting of income before taxation of RM51.7 million and non-cash adjustments for depreciation of RM0.2 million, amortisation of borrowings transaction cost of RM1.0 million and 25% of manager's management fee payable in units amounting to RM3.1 million.

Pavilion REIT has expended approximately RM23.4 million of its capital commitment during the year mainly for development of a new retail space at the end of Couture precinct, glass kiosks outside Fashion Avenue, non-halal foodhall at level 1 and upgrading of cooling tower at Pavilion Kuala Lumpur Mall.

The income before taxation for the current quarter under review was lower by RM10.8 million as compared to the last immediate quarter mainly due to additional rent rebates for tenants that were not providing essential services and supplies during the full and enhanced movement control periods.

B3 Prospects

As per Retail Group Malaysia, the 1st quarter this year recorded a negative growth rate of 10% in retail sales as compared to the same period in 2020. However, with the imposition of movement control order from May 2021 that disallowed most retail businesses from trading, many retailers are struggling and finding it hard to sustain further if the lockdown continues. Numerous businesses and retailers' associations have appealed for targeted measures to be implemented eg building-by-building lockdown instead of blanket lockdown. With vaccination rate progressing well, gradual recovery in the retail industry is expected to begin towards the end of this year.

In the meantime, Pavilion REIT malls are supporting its retailers with rebates, digital marketing promotion, providing drive-thru pick up area and engaging consumers with community messages as well as essential business updates. Social medias are primarily use as a key platform for contest offering shopping and dining vouchers.

B4 Investment Objectives

The Manager's key objective is to provide unitholders with regular and stable distributions and achieve long term growth in net asset value per unit, while maintaining an appropriate capital structure.

B5 Strategies and Policies

The Manager's strategies and policies as reported in the latest annual report remain unchanged, ie to increase the income and consequently, the value of its investment properties and continue Pavilion REIT's growth through the following strategies:-

- a) proactively managing its investment properties and implementing asset enhancement strategies;
- b) actively pursuing acquisition opportunities in accordance with the authorised investments of Pavilion REIT stated in the Trust Deed; and
- c) pursuing an efficient capital management strategy.

B6 Income Distribution

Pursuant to Section 61A of the Income Tax Act 1967, the withholding tax rate applicable on the recipients of income distribution is as follows:-

Resident Unitholder

a) Resident company: Tax flow through, thus no withholding tax

b) Unitholder other than resident company: Withholding tax at 10%

Non-Resident Unitholder

a) Non-resident company: Withholding tax at 24%
 b) Non-resident institutional investor: Withholding tax at 10%
 c) Non-resident, other than company and institutional investors: Withholding tax at 10%

As per the distribution policy stated in the Trust Deed, the Manager intends to distribute at least 90% of Pavilion REIT's distributable income on a half yearly basis. For the financial year ending 31 December 2021, Pavilion REIT proposes to distribute 100% of its distributable income.

Distribution of 2.52 sen per unit or RM76.7 million earned for 2nd half of 2020 was distributed on 26 February 2021. The proposed interim income distribution for the six months ended 30 June 2021 is 1.83 sen per unit or RM55.7 million. The proposed interim income distribution will be payable on the 10 September 2021.

Pursuant to Section 61A of the Malaysian Income Tax Act, 1967 ("Act"), income of Pavilion REIT will be exempted from tax provided that at least 90% of its total income (as defined in the Act) is distributed to the investors in the basis period of Pavilion REIT for that year of assessment within two months after the close of the financial year. If the 90% distribution condition is not complied with or the 90% distribution is not made within two months after the close of Pavilion REIT financial year which forms the basis period for a year of assessment, Pavilion REIT will be subject to income tax at the prevailing tax rate on its total income. Income which has been taxed at the Pavilion REIT level will have tax credits attached when subsequently distributed to unitholders.

As Pavilion REIT proposes to declare 100% of its distributable income to its unitholders for the financial year ending 31 December 2021, no provision for taxation has been made for the current quarter.
