ADMINISTRATIVE GUIDE FOR THE EXTRAORDINARY GENERAL MEETING (“EGM”)

Day and Date	:	Thursday, 5 September 2024
Time	:	11.30 a.m. or immediately following the conclusion of the Seventieth Annual General Meeting of RCE which will be held at 10.30 a.m. on the same day via the same meeting platform, whichever is later

RCE Capital Berhad will conduct its EGM on a fully virtual basis through live streaming and online remote voting using the remote participation and voting facilities hosted on Securities Services e-Portal at <https://sshbsb.net.my/> provided by SS E Solutions Sdn. Bhd.

With the use of remote participation and voting facilities, the members may exercise their rights to participate, speak (in the form of typed text messages) and vote at the general meeting from their respective locations.

Remote Participation and Voting (“RPV”)

1. Only members whose names appear on the Record of Depositors on 29 August 2024 shall be eligible to participate and vote at the EGM or appoint proxy(ies) to vote on their behalf.
2. Members who wish to participate at the EGM are required to register as a user of Securities Services e-Portal as well as register for the remote participation via <https://sshbsb.net.my/>. *Please refer to the Securities Services e-Portal User Guide in Appendix I.*
3. Securities Services e-Portal is an online platform that will allow both individual shareholders and body corporate shareholders, through their appointed representatives to:
 - (a) Submit proxy form electronically - paperless submission
 - (b) Register for RPV at meetings
 - (c) Participate in meetings remotely via live streaming
 - (d) Vote online remotely on resolution(s) tabled at meetings

Appointment of Proxy

1. If a member is unable to participate at the EGM via the RPV facilities, he/she may appoint not more than two (2) proxies to participate and vote on his/her behalf. He/she may also appoint the Chairman of the Meeting as his/her proxy and indicate the voting instructions in the proxy form.
2. If you wish to participate at the EGM yourself, please do not submit any proxy form. A member will not be allowed to participate at the EGM if his/her proxy/proxies has/have been registered to participate at the EGM.
3. The appointment of proxy may be made in hardcopy form or by electronic means as follows:

In Hardcopy Form

The proxy form must be deposited at SS E Solutions Sdn. Bhd. at Level 7, Menara Milenium, Jalan Damanlela, Pusat Bandar Damansara, Damansara Heights, 50490 Kuala Lumpur, Malaysia, no later than **11.30 a.m. on Tuesday, 3 September 2024.**

By Electronic Means

The e-proxy form must be electronically lodged via Securities Services e-Portal at <https://sshbsb.net.my/> no later than **11.30 a.m. on Tuesday, 3 September 2024.** *Please refer to the Securities Services e-Portal User Guide in Appendix I.*

4. Appointed proxies need not register for remote participation but are required to register as users of Securities Services e-Portal latest by **Sunday, 1 September 2024**.
5. If you have submitted your proxy form and subsequently decide to appoint another person or wish to participate personally in the EGM, please write in to eservices@sshsb.com.my no later than **11.30 a.m. on Tuesday, 3 September 2024** to revoke the earlier appointed proxy.

Submission of Questions

1. Members and proxies may submit questions before the EGM via email to egm@rce.com.my no later than 11.30 a.m. on **Monday, 2 September 2024**. Kindly state your full name and MyKad/passport number for verification purposes.
2. Members and proxies may also submit their questions via the real time submission of typed texts through a text box within Securities Services e-Portal before the start or during the live streaming of the EGM.
3. The Board/Management will endeavour to respond to the relevant questions during the EGM or by email after the EGM.

Poll Voting

1. The voting at the EGM will be conducted by poll in accordance with Paragraph 8.29A of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad. The poll will be conducted by way of electronic voting (“eVoting”). Poll Administrator and Independent Scrutineers will be appointed to conduct the polling process and verify the results of the poll, respectively.
2. Access to eVoting will be opened from the commencement of the EGM until the end of the voting session which will be announced by the Chairman of the EGM. Upon completion of the voting session, the Independent Scrutineers will verify the poll results followed by the Chairman’s declaration whether the resolution is duly passed.

No Gift/Voucher

There will be NO distribution of gift/voucher to members/proxies who participate in the EGM.

Securities Services e-Portal User Guide

BEFORE THE EGM	
(A) Register as a user of Securities Services e-Portal	
<p>Step 1: Visit https://sshsb.net.my/ to register as a user (registration is free). Please click on “Sign Up” to begin. You will be prompted to fill in your details and also to upload a copy of your MyKad (front and back separately) or passport.</p> <p>Step 2: A notification email will be sent to you within one (1) working day. Please verify your user account within seven (7) days of the notification email and log in. (Note: Your email address is your User ID)</p>	<p>Notes:</p> <ol style="list-style-type: none"> 1. This is a ONE-TIME Registration. If you are already a registered user of Securities Services e-Portal, you need not register again and may proceed to either (B) or (C) below. 2. To register for remote participation at the EGM under (B) below, please sign up for a user account latest by Tuesday, 3 September 2024. 3. To submit e-Proxy Form under (C) below, please sign up for a user account latest by Sunday, 1 September 2024, failing which you may only be able to submit the hard copy proxy form.

(C) Submission of e-Proxy Form	
<p>Step 1: Log on to https://sshsb.net.my/ with your registered User ID (email address) and password.</p> <p>Step 2: Select “RCE Capital Berhad EGM on 5 September 2024 at 11.30 a.m. - Submission of Proxy Form” under Event tab and click “>”.</p> <p>Step 3: Select whether you are submitting the proxy form as (1) Individual Shareholder; or (2) Corporate or Authorised Representative of a body corporate¹.</p>	<p>Notes:</p> <ol style="list-style-type: none"> 1. Please submit your proxy form latest by Tuesday, 3 September 2024, 11.30 a.m. if you wish to appoint proxy(ies) to participate on your behalf. 2. You are strongly encouraged to appoint the Chairman of the meeting as your proxy if you are not able to participate remotely. 3. A copy of your submitted e-Proxy Form can be accessed via My Records. 4. You need to submit your e-Proxy Form for every CDS account(s) you have or represent. 5. Appointed proxies need not register for remote participation under (B) above but are required to be registered users of Securities Services e-Portal by Sunday, 1 September 2024. Please notify your proxy(ies) accordingly.

¹ For body corporates, the appointed Corporate/Authorised Representative must upload the evidence of authority (e.g. Certificate of Appointment of Corporate Representative, Power of Attorney, letter of authority or other documents proving authority). Any document that are not in English or Bahasa Malaysia must be accompanied by a certified translation in English in one (1) file. The original evidence of authority and translation thereof, if required, have to be submitted to SS E Solutions Sdn. Bhd. at Level 7, Menara Milenium, Jalan Damanlela, Pusat Bandar Damansara, Damansara Heights, 50490 Kuala Lumpur, Malaysia for verification before the registration or proxy form submission closing date and time.

<p>Step 4: Enter your CDS account number or the body corporate's CDS account number.</p> <p>Step 5: Enter the information of your proxy(ies) and the proportion of securities to be represented by your proxy(ies).</p> <p>Step 6: Proceed to indicate how your vote is to be cast for the resolution.</p> <p>Step 7: Review and confirm your proxy form details before submission.</p>	<p>6. Upon processing the proxy forms, remote participation access will be granted to the proxy(ies) instead of the shareholder, provided that the proxy(ies) must be a registered user of the e-Portal, failing which, the proxy will not be able to participate at the EGM.</p> <p>7. Upon verification by SS E Solutions Sdn. Bhd. with the General Meeting Record of Depositors as at 29 August 2024, you will receive an email advising you if your registration for remote participation/ submission of e-Proxy Form is approved or rejected.</p>

(A) Joining the Live Stream Meeting	
<p>Step 1: Log on to https://sshsb.net.my/ with your registered User ID (email address) and password.</p> <p>Step 2: Select "RCE Capital Berhad EGM on 5 September 2024 at 11.30 a.m. - Live Stream Meeting" under Event tab and click ">" to join the EGM.</p>	<p>Notes:</p> <ol style="list-style-type: none"> 1. You can start to log in at any time from 11.00 a.m. i.e. 30 minutes before the commencement of the EGM. 2. If you have any questions that you wish to raise, please use the text box to submit your question. The Board/Management will endeavour to respond to your question during the EGM. 3. Quality of the live streaming is dependent on the stability of the internet connection at the location of the user.
(B) Remote Online Voting during the EGM	
<p>If you are already accessing the Live Stream Meeting, click "Proceed to Vote" under the live stream player;</p> <p>OR</p> <p>If you are not accessing from the Live Stream Meeting and have just logged in to the e-Portal, select "RCE Capital Berhad EGM on 5 September 2024 at 11.30 a.m. - Remote Voting" under Event tab and click ">" to remotely cast and submit vote online for the resolution tabled at the EGM.</p> <p>Step 1: Cast your vote by clicking on the radio buttons for the resolution and review your vote cast and submit the vote.</p> <p>Step 2: Upon casting your vote, you will be redirected automatically to the Live Stream Meeting or you may rejoin the Live Stream Meeting for the poll result announcement, (Please refer to Step 2 under "(A) Joining the Live Stream Meeting" above).</p>	<p>Notes:</p> <ol style="list-style-type: none"> 1. Access to eVoting will be opened on the abovementioned date and time. 2. Your vote cast will apply throughout ALL the CDS accounts you represent as an individual shareholder, corporate/authorised representative and proxy. 3. If you are attending as a proxy, and the shareholder who appointed you has indicated how the vote is to be cast, we will take the shareholder's indicated vote in the proxy form. 4. Access to eVoting will close when the Chairman announces the closing of the voting at the EGM. 5. A copy of your submitted eVoting can be accessed via My Records.
