The Company provides meeting allowances for Directors in accordance with our Remuneration Policy for Directors, which applies to their participation in meetings. For expenses related to the EGM, we adhere to a well-established procurement system. This ensures fair vendor selection and efficient management of all associated costs.

Additional Response

As detailed in Ordinary Resolution 2 in our 10th AGM, Non-Executive Directors (NEDs) receive a meeting allowance of RM500 per meeting for attending Board or Board Committee Meetings. The total benefits payable to NEDs for the current period are capped at RM200,000. This resolution and remuneration amount were approved at the 10th AGM and published in our Corporate Governance Report on page 54. Any revisions or additional fees will be tabled at the next AGM for review and approval from the shareholders. The total expenditure for our online EGM is approximately RM20,000, which includes set-up costs, poll administrator fees, scrutinizer fees and IT support. We ensure that all costs are managed efficiently and justifiably to facilitate effective shareholder engagement.
