Notes:-

- The 10th AGM will be conducted virtually through livestreaming and online remote voting using Digital Ballot Form provided by the appointed Poll Administrator for the 10th AGM, Mega Corporate Services Sdn Bhd. The Broadcast Venue is strictly for the purpose of complying with Section 327(2) of the Companies Act 2016 which requires the chairperson to be present at the main venue of the meeting. No unitholders/proxies/corporate representatives from the public will be physically present at the Broadcast Venue on the day of 10th AGM. Unitholders who wish to participate and vote remotely at the 10th AGM will therefore have to register via the link https://vps.megacorp.com.my/tXah2D. Kindly refer to the Administrative Notes for 10th AGM for further information.
- For the purpose of determining a unitholder who shall be entitled to participate and vote remotely at the 10th AGM, Sunway REIT shall be requesting the Record of Depositors as at 19 April 2023. Only a depositor whose name appears on the Record of Depositors as at 19 April 2023 shall be entitled to participate in the said meeting or appoint proxies to participate and vote remotely on his/her behalf. A proxy may but need not be a unitholder.
- A unitholder may appoint up to 2 proxies to participate and vote remotely at the same meeting.

 Where a unitholder is an authorised nominee as defined under the Securities Industry (Central Depositories) Act 1991 (SICDA), it may appoint at least 1 proxy but not more than 2 proxies in respect of each securities account it holds with units of Sunway REIT standing to the credit of the said securities account.
- Where a unitholder is an exempt authorised nominee as defined under the SICDA, who holds units in Sunway REIT for multiple beneficial owners in one securities account (Omnibus Account), there is no limit to the number of proxies which the exempt authorised nominee may appoint in respect of each Omnibus Account it holds with units standing to the credit of the said Omnibus Account.
- Where a unitholder or the authorised nominee appoints 2 proxies, or where an exempt authorised nominee appoints 2 or more proxies, the appointment shall be invalid unless he/she or it specifies the proportion of his/her or its holdings to be represented by each proxy.
- If a unitholder has appointed a proxy or proxies (not more than 2 proxies) to participate in the 10th AGM and subsequently he/she participates in the 10th AGM, the appointment of such proxy shall be null and void, and his/her proxy shall not be entitled to participate in the 10th AGM.
- The instrument appointing a proxy, in the case of an individual, shall be signed by the appointer or by his attorney duly authorised in writing, and in the case of a corporation, shall be executed under its Common Seal or under the hand of an officer or attorney of the corporation duly authorised.
