UMW (UMWH MK)

Playing Catch-Up In 2H21

- Maintain NEUTRAL and MYR2.94 TP, 8% downside with 2% yield.
 UMW's 1H21 missed our and Street's expectations, with 2Q21 falling into
 the red. We expect UMW to play catch up in 2H21. Vehicle demand should
 remain elevated throughout 2H21, supported by the Sales & Service Tax
 (SST) exemption until 31 Dec and low interest rate environment. Current
 UMW Toyota Motor (UMWT) outstanding orders of c.20,000 units should
 be fulfilled in FY21. UMW's aerospace wing should see a 2H recovery,
 following increased global aircraft deliveries.
- Missed expectations. UMW reported 2Q21 core losses of MYR14.2m, derailing our earlier expectations for it to remain profitable during this quarter. 1H21 core earnings of MYR73.3m (+370% YoY from a low base) missed our and Street's estimates, at only 35% and 25% of full-year forecasts. The main deviation: Mainly from a weaker-than-expected automotive segment and lower share of results from JV/associates.
- FMCO-derailed recovery trajectory. 2Q21 automotive segmental revenue was lower QoQ, with PBT margins (ex-associates) down 1.9ppts to 0.5% (2Q20: -1.3%). We understand this was due to unfavourable FX movements and disruption in activities. UMW's equipment segment also saw weakness in topline, but PBT was buoyed by better performances from the industrial equipment sub-segment, cost-optimisation exercises undertaken by this sub-unit, and lower FX losses for the period. Its manufacturing & engineering division was impacted by lower delivery of fan cases, with a 2Q21 LBT of MYR6m (1Q21 and 2Q20 PBTs: MYR8m and MYR8m).
- Playing catch-up in 2H. UMW's Bukit Raja and Shah Alam manufacturing
 plants are currently operating at utilisation rates of 80% and 95%, producing
 c.400 units/day in total. Meanwhile, vendors have sufficient parts till midOctober. We continue to take the view that Toyota vehicles are likely to be
 relatively unaffected by the global chip shortages, as UMWT's top sellers
 are unaffected. Conversely, we keep our conservative stance on its nearto mid-term outlook over concerns of persistent supply chain disruptions
 affecting Perodua.
- We cut our FY21F earnings by 9% after factoring in lower margins for the automotive segment and decrease in Toyota vehicle sales forecast of 64,000 units from 67,000 vs UMWT's FY21 target of 62,000. We keep our TP and 13x FY22F target P/E, which is close to its 3-year mean.
- Downside risks: A COVID-19 resurgence may affect earnings in all segments, while stiff competition in the sector might exert downwards pressure on UMW's bottomline. Slower-than-expected normalisation in demand post SST exemption and sustained disruptions in semiconductor chip supplies could also be risks to our earnings estimates. The opposite represents the upside risks.


